 - All sales shall be subject to vendor's standard terms and conditions of sale as they exist at the time of the sale.
 - Customer hereby authorizes Dassel's to fill owned or rented tanks on a regular basis on route, until Dassel's is notified in writing to terminate deliveries.
 - No "will call" deliveries.
